A Message From Our Executive Director

What a challenging year 2020 was! This past year did not just present challenges for the agency. I know that each of us struggled with the fear, dissention, and the uncertainty of our world being turned upside down. But, as you can imagine, the events of the last year have impacted the youth we serve exponentially. They had to deal with all the same negative effects that we did, but now they are asked to stay home from school, there 24 hours a day, placing them in potentially, unhealthy home environments full time with no more in person support from their teachers & mentors. The mental health and well being of the youth we serve always has been, and will continue to be, our first priority. We did our very best to stay in contact with our Families and volunteers, offering a kind ear and referrals to other agencies when needed. We even had a few businesses come forward to help with the basics like groceries and gas for our Families, knowing that they were probably hit harder than most with the economic fall-out of the pandemic.

We as a staff and organization have had to pivot in so many ways; helping our matches adjust to a virtual platform, dealing with work from home orders, the loss of traditional fundraisers, monitoring the mental health and wellness of our agency Families. We also need to be cognisant of the staff and the stresses they were under. Ultimately, I believe that in coming together to better serve our families during this crisis, it has brought us closer together, made us a more effective team. I am so proud of our team, Erika and Leah have both shown unending compassion and reliability through the past year. We are lucky to have assets like them in our organization. The positive work environment that we have created in our office speaks to that hard work. We have fun at work and we are helping to change the lives of local youth, what more can we ask for?

While we have almost come through the other side of this crisis, we have not made it without a few casualties; when the schools closed, we lost our In School Mentoring Program and subsequently we lost that program coordinator as a result. I am confident that the ISM Program will be back as strong as ever come September of 2021! Other casualties have been our annual fundraisers; we have had to cancel Crouse's Cleaners Curl for Kids (x2), Hayes Fry Law Charity Golf Tournament, our Westjet Raffle & the Ultimate Escape Fundraiser as well as many other smaller initiatives throughout the year.



We have had some wins too though, for example, we were able to take advantage of various government programs that kept our staff working full-time. We partnered with the City of Grande Prairie to run the weekly outdoor pool bookings, allowing us to offer swim times weekly to our families and supporters. Instead of being the major sponsor for the cancelled UE, New Horizon Coop agreed to come into 2021 as our Community Sponsor, we were very grateful to receive that continued support from them. 2020 also saw the blossoming of an idea that became the development of the Healing Community Hub. As the namesake suggests, Trevor Healing has been instrumental in the development of this fantastic new space! Not only did he give so much of his time and effort personally, he also brought in new sponsors to keep the space financially viable. We are so grateful for his dedication to our agency.

I would like to extend my gratitude to the people that supported the agency throughout this past year, volunteers, mentors, sponsors, but most notably, our Board of Directors. We are successful because our BBBS GP Team is made up of kind, caring people that truly want to make a difference in the lives of those we serve and the community we live and work in. I continue to be amazed at the dedication of the staff and volunteers. We are so fortunate to live in a community that values volunteering and 'giving back'. We would be nowhere without the commitment of our valuable mentors and volunteers. On behalf of our Little Brothers & Sisters, we send out a huge thank you to all for you that gave us you time and your compassion.

Now, as we can finally see the light at the end of the tunnel, we are more than excited to get back to 'normal'. We are just as excited to find out what that new normal looks like for our agency.

The 13th Annual Ultimate Escape kicked off 2020 and once again the event exceeded everyone's expectations. All funds raised that evening stay in our community and directly help match children and youth with positive, safe and quality mentors. This event grows in size and community support each year and we look forward to that trend continuing in 2022 as we anticipate the easing of pandemic restrictions that put this event on hold for 2021. We are excited to brainstorm new ideas to keep the event fresh and the crowd entertained.

Our 6th annual Crouse's Cleaner's Curl for Kids' event unfortunately had to be cancelled due to covid restrictions but we would like to extend a huge thank you to David Crouse and Jesse Arduini of Crouse's Cleaners for pledging their continued support for this event when we are able to safely hold it again. We were also forced to cancel the Hayes Fry Law Charity Golf Tournament but we are already looking forward to resuming this event in 2021 once restrictions are lifted.

2020 saw the addition of a fun new event, The Hunt Group Private Wealth Big Little Amazing Race. This idea was originally brought to us by our Vice-President, Nicole Markin, and what a fantastic idea it was! This event allowed us to stay within the restrictions required by Albert Health Services, while still offering a fun, family event for our community. We were all very pleased with the outcomes and revenue from this first year event. We look forward to next year. Thank you Nicole!

We were fortunate to be one of the chosen charities for the Cash & Camping Lottery. We were unable to sell tickets in person this year but online ticket sales were fantastic. The easing of restrictions during the summer also allowed us to plan a summer camp for our youth, and because we facilitated the weekday bookings for the City of GP Outdoor Pool, we were able to give our kids so many great memories!

A special year-end treat for our agency is the Christmas Party, but this year was such a tough year for our Families and youth so we knew that we had to find a way to make sure they all had an exciting Christmas morning. Once again, we had dozen's of toys donated to us by the Big Toy Box/Q99/Big Country and the local Westjet office.



As we do every year, we ensure that we take advantage of all training g opportunities that come our way. An example of this was the AMP/U of A Generational Trauma Series. We deal with youth from all races, religions, and backgrounds but often, we as the caregivers have never been subjected to the events and trauma's that have taken their toll over generations of marginalization. To help our youth, we must understand where they are coming from and know that trauma, more than anything, has shaped their lives.

Staying in touch with the rest of the BBBS federation was more difficult in this year. To combat the feelings of isolation & helplessness within our agencies, the ED group from Alberta met regularly and this has led to the creation of Regional Leadership Teams across Canada. This allowed us to share ideas, finding out what was working with our matches and what was not. Collaboration on group fundraising was essential in this past year as all traditional means of fundraising was on hold. This group was also important for moral support and discussions about the most efficient and respectful way to interact with our National BBBS Office.

In retrospect, much of 2020 was spent worrying about funding and the wellbeing of the youth we serve. I think this helped us to understand that nothing is guaranteed, and we must embrace and respond to change. We must be able to adapt and ultimately that is how we best serve our youth and this community that we all cherish.
